

The Bundle

These Terms and Conditions govern The Bath Spa Start scheme. Please read these Terms and Conditions carefully.

1. Eligibility for The Bath Spa Start - The Bundles

- i. Students must be starting a full-time or part-time undergraduate course at Bath Spa University in September 2022, including students who have deferred their start date from a previous academic year
- ii. Students must be successfully enrolled on their course by the given enrollment deadline which will be specified in your registration email.
- iii. The full-time and part-time undergraduate course must be for a minimum of three years' duration. For the avoidance of doubt, full-time four-year degree options with either a Professional Placement Year or an Integrated Foundation Year will qualify as being a minimum of three years' duration.
- iv. Eligible Students will automatically qualify for The Bath Spa Start scheme and must select their bundle by the deadline stated in these Terms and Conditions.
- v. The Bath Spa Start is not available to students enrolling at Bath Spa University London or at a Bath Spa University partner institution in the UK or overseas.

2. Your Bundle

- i. Provided that they are eligible, students will select their bundle at the point of receiving an offer of a place at Bath Spa University. Students will have the ability to change their bundle up via a form emailed specifically to them. Students can email be@bathspa.ac.uk if they require further support.
Applicants must make a firm choice of the bundle by an advertised deadline. For 2022 entry, this is 23 September 2022.
- ii. After your enrolment is confirmed by Bath Spa University and you have selected your bundle by the deadline, you will receive your activation codes by email approximately one month after enrolment.
- iii. Activation codes will be sent to your Bath Spa University email account only. It is your responsibility to check this account regularly for important information, including your benefits bundle.
- iv. Benefits bundles are not transferable, are non-negotiable and have no alternative cash value.
- v. Whilst we will always act reasonably, Bath Spa University reserves the right to change the content of the bundle at any time and changes will be notified via email to students as soon as possible.
- vi. There are elements within the benefits bundles that are provided by external third parties and there may be instances where we vary a bundle due to circumstances beyond our control. If this happens after the advertised deadline date, we will reopen the existing benefit bundles for you to choose an alternative existing service or alternatively, at our sole discretion, we may

offer you an alternative service as close to the original service as possible where we are reasonably able to do so.

- iv. Eligible students must select their bundles by **23 September 2022** and selections made after this deadline may not be permitted.
