Bath Spa Careers and Employability Service – Ethics and Sustainability Position Statement

Purpose and Commitment:

Bath Spa's purpose is to make the world a better place, one student at a time. We achieve this through our education, research, and business practices. We recognize that continual improvement is essential, and we are committed to learning and evolving.

Sustainability Policy and Strategy:

Our Sustainability Policy aims to minimise our environmental impact and continually improve our performance. Our Sustainability Strategy outlines how we will achieve this, focusing on seven key themes.

Careers and Employability Service Principles:

The Careers and Employability Service supports Bath Spa's sustainability and responsible investment goals, ensuring students and graduates have access to an impartial service that aligns with their values and aspirations. Our guiding principles include:

- **Employer Relationships**: We do not actively develop relationships with or source vacancies from employers in the oil and gas, fossil fuels, mining, and tobacco industries.
- Promotion of Vacancies: We do not promote vacancies from these industries through
 events, newsletters, social media, sponsorships, or marketing campaigns. We also will
 not add vacancies to our jobs board on MyCareer ourselves. However, they may be
 posted by our third party supplier¹ as part of their core service.
- Advertising Guidelines: Vacancies from non-excluded employers may be advertised on MyCareer if they adhere to our Advertising Guidelines, ensuring impartiality as per the AGCAS Code of Ethics.
- Job Role Standards: In accordance with our Advertising Guidelines and associated decision tree, we approve job advertisements on MyCareer only if they meet standards such as being paid at the National Living Wage. All opportunities are screened before approval.
- Sustainability in Career Decisions: We support students and graduates by providing information about prospective employers' sustainability practices and encouraging transparency. This includes:
 - Self-assessment questions in the employer registration process on MyCareer, published on the employer profile.
 - o A resource for informed labour market research.

Engagement with Ethical Employers:

Reflecting our Social Enterprise Gold Mark achievement, we engage with and source opportunities from employers and suppliers committed to sustainability, ethical practice, and social justice. We prioritize these organizations for internally funded opportunities, such as graduate placements.

Sustainable Service Operations:

Aligned with Bath Spa's Sustainability Strategy and Climate Emergency Declaration Pledge, we operate a sustainable service by prioritising paper-free promotions and purchasing giveaways from approved, sustainable suppliers. We encourage visiting employers to consider the sustainability of their promotional items.

We recognise this position oversimplifies a highly complex issue, and Bath Spa's Responsible

Investment Policy outlines in more detail the University-wide approach to key Environmental, Social and Governance issues.
