Financial Regulations	Amendment	The Board of Governors is responsible for the effective and efficient use of resources, the solvency of the University and for the safeguarding of assets. The Financial Regulations of the University form part of the overall system of accountability and fiscal management and control in support of these responsibilities which is overseen by the Board of Governors Finance and Infrastructure Committee. These Financial Regulations are BSU's rules for controlling resources and providing assurance of regularity and propriety. All staff must comply. Revisions have been made due to requirements for regular review, structural changes instigated regarding capital expenditure and due to the new finance system installation.
