### **Programme Overview**

This programme will enable you to gain a career-enhancing postgraduate legal qualification that will equip you to become a potential lawyer of the future. It is designed to support you to make progress towards legal qualification in England and Wales, covering the seven foundations of legal knowledge and offering preparatory learning for part 1 of the external Solicitors Qualifying Examination (SQE). Bath Spa University is designated by the Solicitors Regulation Authority as an authorised SQE education provider.

You will undertake eight core (15 credit) modules and select one project (60 credit) module option. This learning structure will enhance your academic and organisational skills, develop new legal skills and knowledge, and offer the opportunity to work with external partners to support clients with a range of legal problems.

Alternatively, you can undertake a supervised research project on a legal subject of your choice.

### **Programme Aims**

- 1 Engagement in a challenging programme of postgraduate legal education preparing you to flourish in the domestic and global legal services environment.
- 2 Equip you with a systematic, critical and functional understanding of the seven foundations of legal knowledge, enabling you to innovate, apply established legal principles and solve realistic client-based problems.
- 3 Prepare you to undertake part 1 of the external Solicitors Qualifying Examination.
- 4 Provide a learning environment that enables you to develop in-depth understanding of the complex domestic and global factors economic, social, ethical, political, ecological, technological that shape the creation, interpretation and implementation of the law.
- 5 Make you an ethically aware and independent critical thinker who can evaluate and challenge the positive and negative effects of legal regulation and professional behaviour.
- 6 Develop your creativity, reflective skills and resilience through professional and personal development.
- 7 Encourage autonomous learning and original enquiry across a range of legal subject areas.
