



Bath Spa University: 'Learning Innovation' Editorial Board: Terms of Reference

29th September 2025. The terms of reference will be reviewed annually.

Purpose

The volunteer Editorial Board will provide scholarly input, oversight, contacts, and moral support to the BSU 'Learning Innovation' publication.

Duties and responsibilities

The Editorial Board will ensure and enhance the publication's reputation as a trusted source of high-quality scholarship, through:

- Attending and contributing to Editorial board meetings, or providing contributions to the Editor where attendance isn't possible;
- Representing and promoting the publication to colleagues and students at BSU and externally, with the aim of growing the publication's community of contributors and readers;
- Contributing, peer reviewing and/or co-editing content;
- Providing critical review and advice on the overall publication;
- Providing advice and feedback on the development of the publication, e.g. scope and focus of the publication, thematic editions, commissioning opportunities, appointment of new Editorial board members, relevant conferences and promotional opportunities, etc.
- Upholding the publication's and BSU values of inclusion, respect, collaboration and sustainability, through alignment to ethical publication practices as set out in the Principles of Transparency and Best Practice in Scholarly Publishing.

Membership

The Editorial Board Membership is made up of individuals who have an interest and/or expertise in learning & teaching evaluation, research and scholarship in higher education. Members are committed to open access, data sharing and innovation in scholarly publishing.

The Editor and Members comprise members of staff and, where appropriate, students of Bath Spa University or its partner institutions. External members may also be appointed where their role and expertise are of relevance to the Board.

The Editorial Board is chaired by the Editor(s), and Members are appointed by the Editor(s) for a two-year renewable term. The roles of Editor and Member are voluntary and non-remunerated. Membership is representative of all BSU Schools and relevant professional services / senior leadership and partner institutions. Additional members from other relevant professional services / senior leadership, partner institutions or external organisations will also be considered. Membership is for two years from the date specified and may be extended, if appropriate. Members may step down, and a suitable replacement found, at any time for extenuating circumstances.

Co-editors will be selected on a voluntary basis from the Editorial Board members.
